a message from our CEO

Thank you so much for fundraising for Northamptonshire Domestic Abuse Service (NDAS)! We began under the name of Northampton Women's Aid in 1976. Originally staffed by volunteers the organisation has changed a great deal since then but has always been dedicated to helping and supporting the victims of domestic abuse. We now employ over 40 staff and have 20 wonderful volunteers.

The demand for our services has never been greater, especially for our work helping children to recover from the trauma of domestic abuse in the home. We have had to close our waiting lists we cannot meet the demand.

Without the help of our amazing supporters we would not be able to do as much as we do. Thank you for fundraising for us, it really means the world. Every single penny you raise goes to helping vulnerable families and individuals in Northamptonshire.

Kofi's Story

Kofi is 10 and lives with his mother and half-sister Abena aged 6. Kofi has not had contact with his biological father for 5 years due to historical abuse towards his mother. Kofi's school referred him to NDAS for support due to concerns that they had about his behaviour. It was felt that due to the historical abuse, as well as more recent abuse that his mother was subjected to by his step father (his half sisters father) has had a large impact on Kofi.



Kofi was behaving in an overprotective way towards his mother and sister Abena. He was also highly anxious around contact his sister was having with her father and struggled with low self esteem. He found it difficult to concentrate at school and his attendance was poor.

Our Children's Worker helped Kofi through 12 one to one support sessions held at school over 12 weeks. She supported Kofi to identify healthy and unhealthy behaviours in relationships, reminded what an "adult" worry was and that it was not his responsibility to look after his mum and sister. He was also helped to identify triggers for anger and supported to create coping strategies.

Since the support ended, Kofi's mother has said that their relationship is much improved, and that Kofi seems to be less anxious in general. He will continue receiving support in school and they will support him in his transition to secondary school.

Do you need some form of licence?

Remember that a fundraising event still needs to follow the same regulations as any other event, so it's worth getting in contact with your local council to discuss any permissions that you might require to carry it out without falling foul of the law.

How is the money being controlled?

Collecting money can be a sensitive issue and you need to make sure that you are following the correct procedures throughout. At least two individuals should be involved in counting and recording the money. And any cash that has been collected at your event should be given to the charity asap.

Do you have the correct charity information on your fundraising materials?

Any leaflets or posters need to include the registered charity number, the full company name and the registered address. (all info on front of this pack!)

Can you run a raffle?

It should be noted that you may need a licence if you want to hold a raffle at an event. Small scale raffles are fine, but if you are advertising tickets to be sold to the general public prior to the event, this may require a licence as it is considered to fall under gambling law.

Can you run a charity auction?

You do not need any specific licence to carry out an auction. However, it's important that you should follow any consumer legislation relating to auctions. There are regulations surrounding auctions indicating that you need to ensure items have been valued correctly and accurately. There may also be more specific regulations depending on the kinds of items that you are auctioning.
